



REGULATIONS FOR ADMISSION & MEMBERSHIP

1. Membership is by competitive audition. A fee of \$20.00 is charged first-time applicants. For more details see *GVYO Information about Auditions*.
2. Membership is limited to young persons presently taking lessons on their chosen instrument, and teacher approval will be obtained before membership is confirmed.
3. Applicants are judged according to the following criteria:
 - a. Musicianship
 - b. Special talent
 - c. Instrumental ability
4. Members are required to prepare their parts individually.
5. Regular attendance at rehearsals is obligatory. Players are required to notify the Orchestra Manager if they must miss a rehearsal.
6. Each member will be supplied with music and a music folder for which he or she will be responsible. The music is valuable and must be treated with care. Markings are to be made lightly, WITH PENCIL.
7. Courteous, responsible, and considerate behaviour is expected from members at all times.

MEMBERSHIP FEE STRUCTURE

- **New** members: \$290 (\$275 membership + \$15 music fee)
- **New** second family members: \$265 (\$250 membership + \$15 music fee)
- **Returning** members: \$275
- **Returning** second family members: \$250
